#### Introduction of SWAp- two sets of activities:


- 1. Horizontal Activities
  - Define the Sectors that will be the carriers of sector approach, and preparation of comprehensive multi annual strategies for each of them
  - Review Sector Strategies as well as prepare the standardized methodology for strategies' preparation
  - Ensure linkages between existing national budget frameworks, donor coordination frameworks, public finance management procedures and planning and monitoring mechanisms
- 2. Sector-level Activities (Judiciary, Environment)
  - A Review of the Environment sector policies and strategies and identifying a reference strategic document/ plan
  - Preparation of the Environment sector budget and its medium term perspective
  - Establishment of functional coordination structures
  - Developing of a sectoral performance assessment framework (PAF) to monitor the progress

1 Aid Coordination Group had initial meeting (Agriculture)
Besides Environment, 4 Aid Coordination Groups had preparatory meetings, development of Rules of Procedures, Aid Coordination Group kick off meeting expected by the end of 2011 (Judiciary, Roma Integration, Transport, Energy)


